This request for expressions of interest follows the General Procurement Notice for this project that appeared in UNDB with reference no. WB1292-03/15 on March 18, 2015.

The Republic of Turkey has been allocated grant funds from the European Union Instrument for Pre-Accession Trust Fund which are administered by the International Bank for Reconstruction and Development (IBRD) and executed by the General Directorate of Foreign Relations and EU of the Ministry of Energy and Natural Resources (MENR). MENR intends to apply the funds to eligible payments under the contract for Consulting Services for Long-Term Energy Scenarios, Capacity Building under IPA 2013 Energy Sector Program Phase-2.

The scope of the consulting services ("the Services") will include the review, development and implementation of short/medium/long-term planning and demand/supply forecasting models based on the results of studies conducted under IPA 2012 Energy Sector Program Phase-1 Project. The Services will support MENR to establish an energy data center, develop long-term energy scenarios and enhance capacity to analyze and utilize the data collected for modelling and scenario formation. The duration of services is envisaged as 18 months.

MENR now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are:

- Experience in energy sector data collection, analysis and consolidation
- Experience with establishment of energy data centers
- Experience with relevant Acquis; transparency and third part access regarding market data
- Experience in energy sector (short, medium and long term) planning and modelling, as well as long term energy scenarios
- Experience in optimum generation expansion planning models (short/medium/long term) for energy sector,
- Experience in energy sector demand/supply and price forecasting models,
- Training capacity on the above mentioned subjects,
- Staffing capacity in preparation/implementation of the above.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's [Guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011](#) (revised July 2014) ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate to enhance their qualifications. The "association" may take the form of a Joint Venture or a sub consultancy. In case of a Joint Venture (JV), all members of the JV will be evaluated jointly for the purpose of short listing and shall be jointly and severally liable for the assignment and shall sign the contract in case of award is made to that JV group. Interested consultants should clearly indicate the structure of their "association" and the duties of the partners and sub consultants in their application. Unclear expression of interests in terms of "in association with" and/or "in affiliation with" and etc. may not be considered for short listing.

A Consultant will be selected in accordance with the Selection Based on Quality and Cost Based Selection (QCBS) method set out in the Consultant Guidelines.
