

# How to become a supplier of the nuclear industry?

### Step 1

Know more of the Customer's needs

VISIT the official site on placement of orders for the procurement of goods, works and services for the needs of the State Atomic Energy Corporation ROSATOM — http://zakupki.rosatom.ru — for placement of procurements that are financed from proprietary funds and extra-budgetary funds.

The official site of the Russian Federation for placing of information on public procurement — http://zakupki.gov.ru/—for placement of procurements that are financed from the federal budget funds.

The official site of the Russian Federation for placing of information on procurement for certain types of legal entities — http://zakupki.gov.ru/223/clause/public/home-page.html — for placement of procurements that are financed from proprietary funds and extra-budgetary funds.

On these sites you will find:

- Annual procurement program
- Up-date information on current procurement
- Procurement archive
- Methodological base

Annual procurement program will help you to prepare for participation in procurement procedures: to get additionally required certificates, licenses, to study the prices, to form offers.

Also you can, by selection of specific procurement, to plan their activities more efficiently and to prepare for specific contracts, construction, supplies, pre-study terms of contracts execution, to estimate them with your capabilities.

### Step 2

Find the information on the procurement

#### You should access

http://zakupki.rosatom.ru http://zakupki.gov.ru http://zakupki.gov.ru/223/ clause/pubic/homepage.html Regularly review the information on announced procurement posted on these sites.

On the site http://zakupki.rosatom.ru You can subscribe for the information being of interest for you on procurement provided by the organizations of ROSATOM at the expense of extra-budgetary and proprietary funds in accordance with the Uniform industry procurement standard.

## Step 3

#### Participate in the procurement procedure

Documentation on the procurement of interest is placed on the official sites: zakupki.rosatom.ru — for procurement by means of extra-budgetary and proprietary funds, zakupki.gov.ru — for procurement by means of the budget funds, http://zakupki.gov.ru/223/clause/public/home-page.html — for procurement by means of proprietary and extrabudgetary funds, regulated by the Federal Law as of 18.07.2011 Nº 223-FZ "On the procurement of goods, works and services by certain types of legal entities".

If procurement is carried out in electronic form, then the procurement shall also (in addition to the site) be published on the website of electronic trading platform (ETP). You can participate in such procurement after obtaining accreditation from the ETP operator.

#### Prepare and file an application

You can download the documentation from the official websites and the ETP and to acknowledge with the terms and procedures of procurement. Prepare your application in strict accordance with the documentation requirements.

File your application in the manner, time and at the address specified in the notice. For procurement held in electronic form, please submit your application through Electronic trading platform.
